● Introduction

Your privacy is very important to us. This Privacy Notice(“Notice”) describes how HARBOURCLOUD TECH LIMITED (“we” or “us”) collects, uses, protects, stores, shares, and otherwise processes the personal data of our users of this SecureClean (“App” or “Service”). We encourage you to read this Notice carefully.

● Changes to this Notice

From time to time we may change, modify, or amend this Notice in order to comply with the evolving regulatory environment or reflect the way we operate our business or use technologies.

● Personal data we collect and process

We may collect and process your personal data as follows:

1. Activity Information directly related to your use of the App, includes contact list and or photos.
2. Your name and email address.
3. IP addresses.
4. Device information includes device types and settings, device identifiers (such as IDFA, IDFV for Android, GAID for IOS), browser types, mobile, wireless, operating system versions, another network information (such as internet service provider name, carrier name and signal strength), and application version numbers.
5. Usage data includes the pages of our App you visit, the time and date of your visit, the time spent on those pages, unique device identifiers another diagnostic data.

● How we use the personal data we collect

We use each the information we collect for the following purposes:

1. To provide our App and Service.
2. To personalize and improve our App and Service and your overall user experience.
3. To ensure the security of our online Service and operation of the App.
4. To comply with legal obligations and our policies.

● **How we share your personal data**

We may share your personal data with following third parties:

1. Vendors who help us operate our business (including information technology service providers and marketing agencies that we use).
2. Members of our family.
3. Public authorities and courts.
4. Our professional advisers such as our legal representatives and auditors.

● **Retention of personal data**

Unless a specific retention period is mandated or permitted under applicable law, we will only retain personal data for the duration of time necessary to fulfill the purposes described in this Notice. We will retain and use your data to the extent necessary to manage your relationship with us, personalize and improve your overall user experience, and to comply with our legal obligations, resolve disputes, enforce our agreements, and as otherwise described in this Notice.

● **Protection of personal data**

We use technical, physical, and organizational security measures designed to protect against unauthorized access, disclosure, damage, or loss of personal data and adopt applicable commercially reasonable security safeguards internally and with our third-party service providers to protect personal information.

● **Your personal data rights**

You may have certain following rights under applicable laws:

1. You may have the right to check whether we hold any personal data about you and request access to or copies of such data.
